Students participating in no extracurricular activities were found to have higher odds of using beer or liquor more frequently and in higher quantities than students who participated in two or more extracurricular activities. Odds were slightly less between students who participated in one versus two or more activities. Little or no difference was found in students who consumed wine coolers or wine.
